



## Terms and Conditions of Sale

**Prices** - Yale prices are displayed in U.S. currency and based on FOB factory\* with no local or federal taxes included. All applicable duties and taxes are the responsibility of and to be paid by the invoiced customer. Published prices are subject to change without notice and are not guaranteed against price decline. All orders are subject to acceptance by Corporate Office and will be invoiced at prices in effect at time of shipment.

**Order Value** - Minimum order value of \$750.00 NET per order.. All orders are subject to acceptance by the Corporate Office and will be invoiced at prices in effect at the time of shipment. Orders may be subject to delay or non-fulfillment due to strikes, riots, fires, or other occurrences beyond our control.

**Standard Put-Up** - The standard put-up by product type and size varies and certain products and/or sizes may be subject to minimum manufacturing lengths. The prices displayed on a per foot basis are for reference only and price confirmation should be obtained for pricing of other than standard put-up requirements. Product requirements for other than standard put-ups may require an up-charge and/or additional package costs.

**Freight Policy (Continental US & Canada)** - All freight is FOB point of origin with full freight allowed on orders totaling \$4,500.00 net invoice or over. FFA will only apply to orders shipped via surface transportation within the Continental U.S. and Canada, this excludes Alaska, Hawaii, and Newfoundland. The freight allowance program only applies to a single qualifying shipment to one location. All shipments less than \$4,500.00 net invoice value are FOB point of origin and all associated freight charges will be paid by the customer.

**International Freight Policy - FCA** - factory\* - customer to arrange freight. If recommendation is needed contact the Customer Service Department. Trade Compliance Statement - these items are controlled by the U.S. Government and authorized for export only to the country of ultimate destination for use by the ultimate consignee or end-user(s) herein identified. They may not be resold, transferred, or otherwise disposed of, to any other country or to any person other than the authorized ultimate consignee or end-user(s), either in their original form or after being incorporated into other items, without first obtaining approval from the U.S. government or as otherwise authorized by U.S. law and regulations.
